I hereby agree to sail by the Rules and Conditions published by HISC. I hereby warrant that my yacht will be outfitted, equipped and handled in accordance with these Conditions; that she will have all the required equipment aboard; that she is seaworthy in hull, rig and gear; and that she will be completely manned. I agree that the information as filed with the committee or as amended by the Committee will be the applicable rating for the boat at the time she starts each race.

The Hillsboro Inlet Sailing Club and any other race sponsors are in no way to be held responsible for accidents, damage or injury to property or boats, crew or guests arising from any cause during or related to any race or activities of the Hillsboro Inlet Sailing Club. Weather and sea conditions must be evaluated by each Skipper and his crew and each participant is responsible for determining whether it is safe for them to participate. The responsibility of wearing a life jacket rests upon the Skipper and his crew. If assistance is provided by Committee vessels and personnel, it is at the risk of the participants.

In consideration of your accepting my entry, I do for myself, my executors, my administrators and assigns waive and release any and all claims that I have against the Hillsboro Inlet Sailing Club, and any other sponsors of any HISC event; their officers, directors, members, committeemen, volunteers, employees and agents, or any one or more of them or their executors, administrators, heirs, next of kin, successors or assigns, including any or all claims for damaged caused by the negligence of any of them arising out of my participation or that of my yacht in any race or regatta sponsored by the Hillsboro Inlet Sailing Club and its related activities, including pre-start and post-finish operations and shore activities together with any costs and expenses including attorney's fee that may be incurred as a result of any such claim whether valid or not; and so hereby agree to indemnify and hold harmless each of them against any such claims that an officer, member of my crew or one of my guests (or the executors, administrators, heirs, next of kin, and assigns of any of them) may have or assert together with any costs and expenses including attorney's fees with respect thereto.
