HISC YOUTH SAILING - STATEMENT OF UNDERSTANDING FOR A MINOR CHILD - 2021

NOTICE TO THE CHILD'S NATURAL GUARDIAN; READ THIS FORM COMPLETELY AND CAREFULLY, YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. THERE IS A CHANCE THAT YOUR CHILD MAY BE INJURED BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM, YOU ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM HILLSBORO INLET SAILING CLUB OR BROWARD COUNTY PARKS IN A LAWSUIT FOR ANY REASON.

I hereby authorize my child, _____ to participate in the HISC 2021 Youth Sailing Program. In consideration of the HISC, a not-for-profit Florida corporation, providing sailing instructions to my child, I hereby release, acquit, and discharge the Broward County Parks and Hillsboro Inlet Sailing Club, its members, volunteers and officers from all claims, demands, actions, causes of action (including negligence and/or strict liability), damages, injuries and cost of any nature or kind whether property, personal injury or bodily injury or any other type of injury or damage that may arise from my child's participation in the sailing program as well as the use of the facilities of the park and its equipment. I understand the risks inherent in the sport of sailing and in water sports in general, and in any activity involving children.

I understand that my child will be required to have basic swimming skills and will wear a Coast Guard approved life jacket (type III), water shoes and cloth mask at all times in or around the water. I also attest that my participating child is free and unencumbered from any physical or mental impairment and is free of any contagious or infectious disease that might interfere with his or her health or safety during this program. I agree to abide by the rules, regulations, and policies of the organization, including any and all Covid-19 related safety measures.

I give Authorization to the Hillsboro Inlet Sailing Club for treatment in the event of any accident or injury if I cannot be reached. Any person signing this document as parent or on behalf of a parent agrees to indemnify and hold harmless HISC, its officers, employees, race committees, race participants, guests, agents, or anyone else associated with Youth Sailing from any and all claims or lawsuits in which the child may bring. This indemnification and hold harmless agreement includes, but is not limited to: all damages, settlements, costs, and all attorney's fees incurred in defense of such claims.

I agree to assume the obligation of the expense of repair and/or replacement of equipment whose loss or damage is attributed to my child's reckless or irresponsible behavior.

I also agree that photos or videos of my child may be taken during these events and I give my permission for the use of these photos or videos on any Club websites or brochures.
